Executive Summary

- 6,483 STRs have been received by FMU during the first quarter of the year 2020.
- During the first quarter of the year 2020, 22 Financial Intelligences¹ (FIs) containing 1,104 STRs² have been disseminated to LEAs and Regulators under the suspected offence of Predicate Offence of Terrorism / Terrorism Financing.
- Top 5 Offences during the first quarter of the year 2020, in terms of number of disseminated STRs, are TF-UNSCR-1373 (STRs disseminated=1,086), Tax Crimes (STRs disseminated=1,054), Hawala/Hundi (STRs disseminated=575), Smuggling / Offences under Customs Act (STRs disseminated=560) and Trafficking in human beings and migrant smuggling (STRs disseminated=424).
- Major reporting Sectors include Banks and Exchange Companies.
- Top three STR reporting districts (during the first quarter of 2020) are Karachi, Lahore and Peshawar with 1,385; 820 and 571 STRs respectively.
- 5,975,046 CTRs have been received since inception till 31-Mar-2020.








