The Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of 30 (Thirty) days after opening of bids.

Interested eligible bidders are required to obtain an electronic (soft) copy of the bidding documents upon submission of a written application to the address below and cash payment of a non-refundable fee of Rs.2,500/- (Rupees Two thousand five hundred only), during working hours after publication of this IFB till closing thereof. This IFB is also being uploaded on the websites <u>http://www.ppra.org.pk</u> and <u>http://www.fmu.gov.pk</u>. The interested bidder shall bring along a USB flash drive to obtain the soft copy of the bidding documents. Bids shall only be accepted from those bidders who accordingly obtain the soft copy of the bidding documents.

Bid security of not less than 03% (three percent) of the bid price must be accompanied with the bid in a separate sealed envelope. Bidders have to submit complete requirements for the bids. Late bids will be rejected. Bids submitted without signed Bid Form by authorized nominee of the bidder will be rejected. Bid with material deviation, exception, objection, conditionality, or reservation will also be rejected.

Bids must be delivered at the office of the undersigned on or before the Bid Closing Date. Bid opening will be at FMU office in the presence of bidders' representatives who choose to attend.
