FMU invites sealed bids (Technical and Financial Proposals sealed in separate envelopes) from eligible bidders for **Procurement of IT Software, Equipment & Licenses** as per details mentioned in the "Technical Specification" in the Bidding Documents.

Bidding will be conducted under Open Competitive Bidding pursuant to 'Single-Stage Two Envelopes procedure' as per Rule 36(b) of Public Procurement Rules (PPR) 2004 and is open to all eligible Bidders as defined in the PPR, 2004 that meet the following minimum eligibility/qualification criteria:

1. *Not blacklisted under the provision of Rule 19 of Public Procurement Rules 2004*
2. *Bidder must be an original equipment manufacturer (OEM) or an agent/partner of the OEM of required equipment in Pakistan with consistently valid PRINCIPAL's authorization certificate for the last 03 (Three) consecutive years or more.*
3. *Bidder must have experience and documented track of 5 (Five) or more similar assignments, during last 03 (Three) years, involving the supply, installation and provision of similar equipment and technical support.*
4. *The bidder may bid for any and all of the following packages:*
 - a. *Package 1: Data Center Precision Air Conditioners (PAC/HVAC) – 2 Units*
 - b. *Package 2: 88Kva Generator*
 - c. *Package 3: Multifunction Devices - 1 unit each*
 - i. *Black & White Multifunction Device (Printer, Scanner, Photocopier and Fax)*
 - ii. *Color Multifunction Device (Printer, Scanner, Photocopier)*
 - d. *Package 4: Network Switches – 2 Units*
 - e. *Package 5: NMS(Network Monitoring system)*
 - f. *Package 6: AMP & URL Filtering Licenses*
 - g. *Package 7: IP-Telephony Communication Manager*
 - h. *Package 8: WAF (Web Application Firewall)*
 - i. *Package 9: Laptops – 6 Units*
5. *Bidder must have Annual Sales volume/Gross Turnover of:*
 - a. *Package 1 and 2: 150 Million rupees or more in each of the last 03 (Three) years.*
 - b. *Package 3, 4, 5, 6, 7 and 8: 50 Million rupees or more in each of the last 03 (Three) years.*
 - c. *Package 9: 10 Million rupees or more in each of the last 03 (Three) years*
6. *Bidder must have verifiable presence/support/branch office in Karachi to provide support and must have technical strength of at least 04 (Four) or more trained Resources for Package 1 through 8.*
7. *Bidders must be registered with the concerned Federal and Provincial Tax Authorities and must also appear on the Active Tax Payer List (ATL) of the FBR.*

The bidders are required to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of 120 (One Hundred and Twenty) days after opening of bids.

Interested eligible bidders are required to obtain an electronic (soft) copy of the bidding documents upon submission of a written application to the address below and cash payment of a non-refundable fee of Rs.2,500/- (Rupees Two thousand five hundred only) for each Package, during working hours after publication of this IFB till closing thereof. This IFB is also being uploaded on the websites <http://www.ppra.org.pk> and <http://www.fmu.gov.pk>. The interested bidder shall bring along a USB flash drive to obtain the soft copy of the bidding documents. Bids shall only be accepted from those bidders who accordingly obtain the soft copy of the bidding documents.

Bid security of not less than **03%** (three percent) of the bid price must be accompanied with the bid in a separate sealed envelope. Bidders have to submit complete requirements for the bids. Late bids will be rejected. Bids submitted without signed Bid Form by authorized nominee of the bidder will be rejected. Bid with material deviation, exception, objection, conditionality, or reservation will also be rejected.

Bids must be delivered at the office of the undersigned on or before **11:00 AM on Friday the 08th of May, 2020**. Bid opening will be on same day at **11:30 AM** in FMU office in the presence of bidders' representatives who choose to attend.
