FMU invites sealed bids (Technical and Financial Proposals sealed in separate envelopes) from eligible bidders for "Renewal of Support and License Subscription for Web Application Firewall (WAF)" as per details mentioned in the "Technical Specification" in the Bidding Documents.

Bidding will be conducted under Open Competitive Bidding pursuant to 'Single-Stage Two Envelopes procedure' as per Rule 36(b) of Public Procurement Rules (PPR) 2004 and is open to all eligible Bidders as defined in the PPR, 2004 that meet the following minimum eligibility/qualification criteria:

- 1. The Bidder should Not be blacklisted under the provision of Rule 19 of Public Procurement Rules 2004.
- 2. The Bidder must be an original equipment manufacturer (OEM) or an agent/partner of the OEM of required equipment in Pakistan with consistently valid PRINCIPAL's authorization certificate for the last 03 (Three) consecutive years or more.
- The Bidder must be authorized by the respective OEM to participate specifically in this tender.
- 4. The Bidder must have experience and documented track of Five (05) or more Web Application Firewall (WAF) assignments, during the last Three (03) years.
- 5. The bidder must have an Annual Sales Volume/Gross Turnover of 350 million or more in each of the last 03 (Three) years.
- The Bidder must have verifiable presence/support/branch office in Karachi and Islamabad to provide support.
- The Bidder must have Technical strength of atleast 03 (Three) Web Application Firewall (WAF) OEM certified resources.
- 8. Bidders must be registered with the relevant Federal and/or Provincial Tax Authorities and must also appear on the Active Taxpayer List (ATL) of the FBR.

The bidders are required to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of 120 (One Hundred and Twenty) days after opening of bids.

Interested eligible bidders may obtain an electronic (soft) copy of the bidding documents upon submission of a written application to the address below and payment of a non-refundable fee of Rs.2,500/- (Rupees Two thousand five hundred only), through deposit in Government Treasury Account (receipt should be provided) during working hours after publication of this IFB till closing thereof. This IFB is also being uploaded on the websites <a href="http://www.ppra.org.pk">http://www.ppra.org.pk</a> and <a href="http://www.fmu.gov.pk">http://www.fmu.gov.pk</a>. The interested bidder may bring along a USB flash drive to obtain the soft copy of the bidding documents or may request bidding documents to be emailed. Bids will only be accepted from the bidders who obtain the Tender Documents, after the due process defined above.

Bid security of an amount PKR.,1,500,000/- (Rupees One Million Five Hundred Thousand) must be accompanied with the Technical Bid in a separate sealed envelope. Bidders have to submit complete requirements for the bids. Late bids will be rejected. Bids submitted without signed Bid Form by authorized nominee of the bidder will be rejected. A bid with material deviation, exception, objection, conditionality, or reservation will also be rejected.

Sealed Bids must be delivered to the office of the undersigned on or before **Wednesday**, **August 30**, **2023**, **at 11:00 AM**. Bids will be opened, in the presence of bidders' representatives who choose to attend, at **11:30 AM on the same day** at FMU Office.
