Transworld (Pvt) Ltd for both packages did not include the required T-Forms or submitted improperly. Additionally, the bid submitted by M/s. Wateen Telecom Limited for Package 2 did not meet the minimum eligibility criteria. Consequently, all bidders for Packages 1 and 2 have been declared technically disqualified.
