10. Details of Bid(s) Evaluation: A detailed evaluation was undertaken against bids submitted by the bidders for packages 1, 2 and 3. Bids submitted by vendors in Packages 1 and 2 are fully compliant with all technical requirements. Whereas the bid submitted by M/s. IT Consulting and Services in Package 3 did not meet the minimum eligibility criteria and hence technically disqualified. However, the bids submitted by other Two (02) vendors in Package 3 are fully compliant with all Technical Requirements.
