2. To use the EPADS, unregistered bidders may first register on website <https://eprocure.gov.pk>. In case of any technical issues during registration or while using EPADS, prospective bidders may contact PPRA's technical support team via the EPADS UAN: 051-111-137-237.

3. The e-bidding documents, in accordance with relevant regulations and containing detailed terms, conditions, specifications, and requirements, are available to registered bidders on EPADS at <https://portal.eprocure.gov.pk>

4. All electronic Bids must be accompanied by a Bid Security i.e., as specified in the table above, in the form of Demand Draft / Pay Order / Bank Guarantee made payable to "**Financial Monitoring Unit, Government of Pakistan**". The prospective bidders are required to upload scanned copy of Bid Security on EPADS.

5. Original bid security must be submitted to FMU before the closing time of bid submission failing which the bid shall be rejected.

6. The electronic bids must be submitted through EPADS. Manual submissions without EPADS submission will **not be accepted**. The electronic Bids will be publicly opened via EPADS on the same day, as per schedule mentioned in the table, at FMU Office, 2nd Floor, Main Building State Bank of Pakistan, I.I. Chundrigar Road Karachi. In case the bid opening date falls on a public holiday, the bids will be opened on the next working day at the same time and venue.
