The bidders are required to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of 90 (Ninety) days after opening of bids.

Interested eligible bidders are required to obtain an electronic (soft) copy of the bidding documents upon submission of a written application to the address below and cash payment of a non-refundable fee of Rs.2,500/- (Rupees Two thousand five hundred only) for each Package, during working hours after publication of this IFB till closing thereof. The interested bidder shall bring along a USB flash drive to obtain the soft copy of the bidding documents. Bids shall only be accepted from those bidders who accordingly obtain the soft copy of the bidding documents.

Late bids will be rejected. Bids submitted without signed Bid Form by authorized nominee of the bidder will be rejected. Bid with material deviation, exception, objection, conditionality, or reservation will also be rejected.
